And whereas, the undersigned is empowered under Epidemic Disease Act, 1897 under sections 2, 3 and 4 to issue directions regarding containment measures to prevent and contain the spread of nCOVID-19 disease and in exercise of the powers vested in me by virtue of section 144 of Cr.P.C. 1973, I, **Anshaj Singh, IAS, District Magistrate, Sonipat** do hereby regulate the operations of vegetable/fruit/milk/dairy products for general public in District Sonipat till further orders. All Sabji Mandies situated in district Sonipat will be fully closed for general public except farmers who will sell their vegetable & fruits in these mandies.

Sh. Mahavir Singh, District Marketing Enforcement Officer, Sonipat will be Nodal Officer for supplying the above essential goods at door steps of public through authorized rickshaws (by Distt. Authority) He will also ensure supply of Milk & Dairy products through these rickshaws.
